

Keeping in view the interests of the students, the Council has taken a conscious decision to grant the institutions yet another opportunity for shifting to permanent site before the commencement of the next academic session i.e. 2004-05. This is the last and final chance given to the institutions and no further appeal in the matter will be entertained. A monitoring visit shall be conducted during the academic year 2003-2004 on the temporary site.

Institutions failing to comply with this direction will be liable for punitive action.

In view of the above decision of the Council and as per the laid down procedure, Guidelines, Norms & Standards of AICTE, I am directed to state that AICTE hereby grants its approval of extension for conducting the PGDPM with annual intake and period of approval is given below :-
